The beginning bank balance was approximately \$4,100 Revenue: new membership dues, \$2,000 from Simpson (\$1,000 toward 2020-21 scholarship, \$500 sponsor funds for our club and another \$500 toward the continuing scholarship for original recipient Brianne). Mark sent a check for \$500 to Chico State for Brianne and it's cleared. Greg Glick sent \$500 to the club for sponsorship of the club. Nothing received as yet from SpeedVentures, CyberScientific or Goodyear.

Expenses: dues paid to NCCC, bank service charge and Tag Ur It badge invoices with an ending balance of approximately \$5,700.

Mark also discussed how important our sponsorship efforts have become in the club and suggested we consider adding someone on the board to handle scholarships, funds and relationships with sponsors, etc. Don Wilder has been doing a great job and perhaps we should add him to the board.

Harold said that Don Wilder and the current committee discussed about getting other people involved and originally were going to bring this up at the June meeting but was sidelined due to COVID 19.

Harold will revisit this with Don and the committee. If we do make it a board position, we need to consider that we would have to rotate every few years. There is a lot involved and maintaining our sponsor relationships are important.

Harold mentioned that we previously talked about sending information to our sponsors earlier in the year so we know what our scholarship fund will be for the following year to avoid late commitments.
